Objection for the following reasons:

- concern over the safety of the proposed pedestrian link, considering the national speed limit
 on the road linking The Green and the A340, the propensity for drivers to use this road as a
 cut-through and drive at high speed, and the necessity for pedestrians to cross the layby in
 use by buses in the proposed plan
- 2. lack of clarity over what the proposed pedestrian link is for and its hours of use, considering the gate between the layby and field is kept locked outside school hours; thus, the intended benefits of the link over pedestrian access via The Green are unclear and likely outweighed by the risk to pedestrians' safety
- 3. the proposed pedestrian link will require removal of established hedgerow and wildlife
- 4. previous comments submitted by Theale Parish Council have not been addressed.

14/20/21 To receive a report from the internal auditor

The previously circulated report was received and the council made no material comments.

15/20/21 To consider a proposal to conduct fitness classes on the recreation ground

Information on the proposal was circulated previously. Following discussion, the council

RESOLVED to provisionally accept the proposal subject to the following conditions:

- that the person who made the proposal ensure the proposed activity does not excessively impinge on the use of the recreation ground by others—such as dog walkers, sports players and residents—and abides by the government's social distancing restrictions;
- ii. that this person not damage the football pitch and, where possible, keep off it;
- iii. that, following discussion with the Interim Clerk and with the above in mind, this person consider use of North Street Playing Fields instead of the field between the Pavilion and Theale Green School: and
- iv. that the person avoid producing noise which may be considered a nuisance.

The council decided to grant the person who made the proposal three months free use of the recreation ground (or North Street Playing Fields) as a trial period, after which a fee will be applied for hire of the space.

The council delegated further action to the Interim Clerk and Chairman.

16/20/21 To approve an increase in the number of litter picks from one to two per week as necessary

Due to the increased use of the recreation ground, it was

RESOLVED to approve an increase in the number of litter picks from one to two per week as necessary.

Cllr Clifford requested that the Interim Clerk or Assistant Clerk ask the contracted litter picker to refrain from posting on matters related to council business on social media.

17/20/21 To accept the quotation from Blachere Illumination UK Ltd for the hire, installation, removal and storage of Christmas lights at a cost of £4,384.86 including VAT

The council asked the Assistant Clerk to ask Blachere Illumination UK Ltd for options for different lights within the current agreement. The council

RESOLVED to accept the quotation at from Blachere Illumination UK Ltd for the hire, installation, removal and storage of Christmas lights at a cost of £4,384.86 including VAT, subsequent to a review of the option for different lights.

18/20/21 As part of the annual review of the council's policies, to review:

- Standing Orders
- Equal Opportunities Policy
- Recording of Meetings Policy

There being no other business the meeting ended at 8.53pm.

Cllr Clifford suggested a paragraph making allowance for "special circumstances" such as the use of video conference during the recent lockdown restrictions be inserted into the Standing Orders, subject to the relevant legislation.

Cllr Clifford also suggested 'Data Protection Act 1998' be changed to 'General Data Protection Regulation'.

Subject to these amendments, the council agreed to accept the listed policies for the next year (to be signed at a later date and reviewed annually).
