**GUIDANCE NOTES
REGISTER OF MEMBERS' INTERESTS**

**The Localism Act 2011
The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012**

Members' attention is drawn to the following notes:

1. The Council's Code of Conduct provides for registration and disclosure of pecuniary interests and interests other than pecuniary interests. This form gives general guidance on those interests that need to be disclosed if you need advice or assistance please speak to the Clerk. Continuation sheets should be used where needed and clearly marked.

c. I understand that failure (without reasonable excuse) to register or disclose any disclosable pecuniary interest in accordance with section 30(1) or 31(2), (3) or (7) of the Localism Act 2011, or participating in any discussion or vote in contravention of section 31(4) of the Localism Act 2011, or taking any steps in contravention of section 31(8) of the Localism Act 2011 is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a member for a period not exceeding 5 years.
