**GUIDANCE NOTES
REGISTER OF MEMBERS' INTERESTS**

**The Localism Act 2011
The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012**

Members' attention is drawn to the following notes:

1. The Council's Code of Conduct provides for registration and disclosure of pecuniary interests and interests other than pecuniary interests. 
